Study Abroad COVID-19 Information and Resources

The purpose of this communication is to inform WU international education participants and supporters about WU Study Abroad Programs.

The Study Abroad Office continues to monitor the evolving situation regarding COVID-19. Working in conjunction with WU leadership (the Vice President of Academic Affairs (VPAA) and our host university partners and affiliate providers we have created the following protocol to evaluate programing. These events, in isolation or together, may compel WU to temporarily suspend or cancel our programs. The VPAA provides the final authorization to allow a program.

- An elevation in the CDC alert level to a 3 (“avoid non-essential travel” recommendation) for the host country; [COVID-19 Travel Recommendations by Destination](#).
- An elevation in the U.S. State Department advisory level for the country to a 4 (“do not travel” status); [U.S. Department of State- International Travel-Country Information](#).
- The host country or U.S. government recommends evacuation or immediate departure for foreign visitors or U.S. citizens, see host country Embassy or Consulate website.

We continue to review and implement new safety protocols as we track developments related to the pandemic and follow CDC guidelines. Data continually shows getting vaccinated is the best way to protect yourself and others. For this reason, and for the health of our partners and host communities around the world, **WU requires program participants to be fully vaccinated and up-to-date on their COVID-19 vaccinations prior to the start of an onsite study abroad program.** To understand if you are up-to-date on your COVID-19 vaccination, please refer to [the CDC COVID-19 Vaccine Booster Shots Chart](#). In short, to be fully vaccinated you should receive a booster if you are 5 months past your last dose of Moderna or Pfizer vaccines OR 2 months past the Janssen/Johnson & Johnson single shot.

The Office of Intentional Programs will make a final determination on whether to cancel programs. We strongly advise students to make contingency plans to study through WU, in case the study abroad program is cancelled. This includes enrolling in courses at WU, confirming housing options, and all other WU requirements.

FAQ's

Will WU's Study Abroad Office Be Able to process Study Abroad Programs in the Coming Academic Year?

The Study Abroad Office facilitates study abroad programs internationally through a global network of WU partners and affiliate organizations. The Study Abroad Office has established criteria that must be met before any students can embark on an onsite in-person exchange. Safety has always been and will continue to be our number one priority. No programs will be allowed proceed unless and until they meet the safety criteria determined by the Study Abroad Office. These criteria include country-specific information related to the current state of the outbreak in each country, along with the governmental and medical infrastructure for dealing with the pandemic, immigration and visa issues and airline restrictions, status of school's delivery of academic programming, social/daily life implications, host university and partner support capabilities, among others. Each program will be assessed individually using the established criteria.

Will the Study Abroad Office Process Faculty-led Study Abroad Programs?

The Study Abroad Office will continue to process Faculty-led Study Abroad Program Proposals. The programs will be evaluated using the established criteria. Each program leader will need to submit a [Travel Safety Summary](#). Faculty leaders will work closely with their program host, vendors, and the WU supporting offices/areas to develop the program and adhere to safety protocols.

How Will the Study Abroad Office Move Forward with Study Abroad Programs?

The Study Abroad Office will evaluate all programs individually and send students to locations that meet the established criteria. The Study Abroad Office will work with program providers and exchange partners to offer Virtual Online Study Abroad Program options.
